### DESTITUTION

Asylum seekers are not entitled to work. 'Failed' asylum seekers are no longer entitled to benefits or housing unless they are prepared to return home, which for many is not possible. The British Red Cross estimates that at least 26,000 destitute asylum seekers are living off Red Cross food parcels in the UK; however, the actual number of destitute asylum seekers is much higher as the Red Cross does not distribute food parcels in all cities, including Exeter. Devon has its own share of asylum seekers who find themselves no longer entitled to Government help and rely on charities such as Refugee Support Group Devon to help.

# Refugee Week

## Different Pasts, Shared Future

Refugee Week is a UK wide programme of events which celebrate the contribution of refugees to the UK. We look forward to seeing you at the variety of events and exhibitions throughout Exeter and Devon this week.

### Who is a refugee?

The 1951 Convention Relating to the Status of Refugees defines a refugee as somebody who has left his or her own country, or who is not able to return to it "owing to a well-founded fear of being persecuted for reasons of race, religion, nationality, membership of a particular social group or political opinion." When a refugee arrives in the UK they are called an asylum seeker until they are granted refugee status which gives them permission to live in the UK. An asylum seeker is a legal term relating to someone who has formally made an application to the government.

### Where are refugees from?

In the UK in 2008 the 10 most common countries people fled from were (highest numbers first) Afghanistan, Zimbabwe, Eritrea, Iran, Iraq, Sri Lanka, China, Somalia, Pakistan and Nigeria.

### Why do they come to the UK?

The UK hosts just a small fraction of the world's refugees, the majority seeking shelter in their neighbouring (and often poor) countries. Of those that are able to seek help in western or developed countries, the UK hosts less than 8% (2008, UNHCR). People may not necessarily choose to come to the UK – safety being their priority. People may seek to come to the UK because they believe we have a fair process of asylum.

### What can an asylum seeker expect from the UK?

The immigration legislation in the UK has undergone many changes over the past 8 years resulting in increasing restrictions on asylum seekers. The Government has passed legislation that has prohibited asylum seekers from working; limited their access to the NHS; reduced the amount of support they can claim; and restricted them to five hours of legal aid per case. Asylum cases may take several years to be processed and individuals are 'liable to detention' at any time.
